It is proposed that the form of the questionnaire remained largely unchanged from 2022-2023. All Specified Amenities are invited to make a presentation to the Funding Board on 6 September 2022 to outline the key features of the proposed funding application.

Recommendation

That the 2023-2024 questionnaire largely follow the format used in 2022-2023. That funding applications are to be submitted no later than 13 September 2022 and all amenities are invited to present to the Funding Board on 6 September 2022 to outline the key features of the forthcoming funding application.

6. <u>2022-2023 FUNDING PLAN – ADOPT FUNDING PLAN AND FIX THE LEVY</u>

Auckland Council will meet on 28 April 2022 to consider the proposed levy of \$16,910,479 for 2022-2023, in accordance with section 30 of the Auckland Regional Amenities Funding Act 2008. If approved, it is necessary for the Funding Board to adopt the Funding Plan for 2022-2023 that confirms the grants allocations and conditions to be made to each specified amenity, and to fix the amount of levy payable by the Auckland Council on 1 July 2022.

If Auckland Council rejects the proposed levy, the processes laid down in the Act will need to be followed in order for the levy to be finalised for 2022-2023.

Recommendation

That the allocation of grants and conditions for 2022-2023 be confirmed; the 2022-2023 Funding Plan be adopted; and the 2022-2023 Levy payable by Auckland Council on 1 July 2022 be fixed as \$16,910,479.

Subject: 2023-2024 Funding Applications and Questionnaire

- 1. When confirming the timetable of meetings for 2022, the Funding Board determined that funding applications for 2023-2024 from the Specified Amenities would close on 13 September 2022.
- 2. This will ensure the board can undertake and conclude all its statutory requirements ahead of publishing the draft 2023-2024 Funding Plan in January 2023.
- 3. In addition to the information requirements laid out in the Act, (specifically section 23), the Funding Board has determined that it also wishes each applicant to submit additional information with the funding application.
- 4. The purpose of this is to enable the directors to gain a greater understanding of each applicant around the nature of their organisation; changes in the operating environment; challenges being faced; and matters affecting the day to day and longer-term operations of each organisation, including the impacts of proposed capital development plans even though capital expenditure is expressly excluded from being funded.
- 5. The annual questionnaire has been developed for applicants to submit along with their funding application as defined under section 23 of the Act. The questions are additional to the funding application and the proposed core questionnaire for 2023-2024 is substantially the same as that used in recent years.
- 6. All applications are to be submitted in an electronic format.
- 7. Due to the ongoing wider impacts of the COVID-19 pandemic, business operations over the last 2-3 years have been, and will continue to be different to what has been considered normal prior to early 2020.
- 8. For the 2021-2022 and 2022-2023 Funding Applications the board introduced additional questions that delt specifically with the effects of the COVID-19 pandemic on the business operations of each amenity. These will carry over to 2023-2024.
- 9. In addition to the funding applications, each Specified Amenity submitting an application is invited to attend a Funding Board workshop on 6 September 2022 to outline the key features of the proposed funding application for 2023-2024.

Recommending:

That the Funding Board:

- A. Requires, in addition to the core information requirements outlined in Act, applicants to provide the additional information requested in the 2023-2024 Funding Application form.
- B. Approves the Funding Application for 2023-2024 to be based on that used for 2022-2023, including the questions focussed on the on-going impacts of the COVID-19 pandemic on the business operations of the applicant.
- C. Authorises the Funding Plan and Annual Report Working Party to update the 2023-2024 Funding Application form to incorporate questions regards the impacts of COVID-19, and any other editorial changes as needed.
- D. Instructs the Advisory Officers that the 2023-2024 Funding Application forms are to be distributed to the Specified Amenities no later than 30 June 2022.
- E. Invites applicants to attend the 2023-2024 Funding Application presentation workshop on 6 September 2022.
- F. Confirms the closing date for 2023-2024 Funding Applications as 13 September 2022.

Subject: 2022-2023 Funding Plan – Adopt the Funding Plan and Fix the Levy

- 1. At its meeting on 15 February 2022 the Funding Board resolved to adopt the draft 2022-2023 Funding Plan and to forward the plan and details of the proposed levy of \$16,910,479 to Auckland Council for consideration and approval.
- All necessary information was forwarded to Auckland Council in sufficient time for the matter to be considered at the Finance and Performance Committee meeting on 17 March 2022. Auckland Council chose to defer the matter until a later meeting in order to assess the impact of the levy on its budget for 2022-2023.
- 3. Auckland Council Governing Body will meet on 28 April 2022 to consider the 2022-2023 Funding Plan and levy of \$16,910,479.
- 4. At the date of this agenda, the outcome of the meeting is unknown and an oral update will be provided at the meeting.
- 5. If the levy is approved, it is necessary for the Funding Board to confirm the final allocation of grants to the specified amenities; adopt the 2022-2023 Funding Plan; and to fix the levy for 2022-2023, (ss 30 and 35 of the Act).
- 6. The Funding Board must give notice of the levy to Auckland Council no later than 30 April 2022.
- 7. Once completed, copies of the final version of the 2022-2023 Funding Plan must be distributed to the eight Specified Amenities and Auckland Council and must be available to the general public upon application.
- 8. A copy of the Funding Plan will be listed on the boards website and public notices published in the New Zealand Herald advising that copies of the plan are available.
- 9. If Auckland Council rejects the proposed levy, the processes laid down in the Act will need to be initiated and followed in order for the levy to be finalised for 2022-2023.

Recommending:

That the Funding Board:

A) Approves the allocation of grants to the eight Specified Amenities as:

B) Confirms the conditions attached to the 2022-2023 grants as follows:

Surf Life Saving Northern Region Inc.

The northern regional surf clubs initiated and co-ordinated a review of Surf Life Saving Northern Region Inc. (SLSNR), with the view to consolidating SLSNR operations into Surf Life Saving New Zealand (SLSNZ) with effect from 1 July 2022. The precise terms of the proposed consolidation, and the impact on SLSNR and its ongoing status as a Specified Amenity are not yet known.

- A. Prior to confirming the final allocation of grants for 2022-23 (circa February 2022), the Funding Board, in its sole discretion, and having regard to the requirements of the Auckland Regional Amenities Funding Act (Act), must be satisfied in all respects with how the proposed SLSNZ consolidation project impacts the operations of SLSNR, including:
 - 1. with the proposed governance, management, and operations of SLSNR from 1 July 2022; and
 - 2. SLSNR's ongoing compliance with the Act and it's purposes; and
 - 3. the delivery of services and community facilities (if applicable) by SLSNR into the Auckland region.

- B. If, between February 2022 and prior to 11 July 2022, the Funding Board, at its sole discretion, is not satisfied with the proposed governance, management, and operations of SLSNR for the 2022-2023 financial year or with the other matters contemplated by condition A above, the grant payment to SLSNR may be reduced or withheld completely, with any amount withheld being returned to Auckland Council.
- C. If at any time during the period to which the funding relates, SLSNR is restructured in a manner that materially changes the nature of what SLSNR does itself, or results in SLSNR no longer providing facilities or services itself or no longer meeting the requirements of a Specified Amenity under the Act, the funding allocated to SLSNR for 2022-2023 will no longer be available to SLSNR, and the Funding Board will have the right to require that some or all of the funding already paid to SLSNR for that year must be promptly repaid to the Funding Board, in which case SLSNR shall repay such amount upon demand. Any amount repaid to the Funding Board will be returned to Auckland Council.

Watersafe Auckland Inc. (Drowning Prevention Auckland)

- A. Of the total proposed increased grant funding for 2022-2023 (+\$53,750), \$33,750 towards CPI increases for staff salaries, and an amount of \$20,000 is specifically allocated as a contribution towards the cost of the proposed new Strategy and Implementation Manager position.
- B. Should the Strategy and Implementation Manager position not be confirmed and an appointment to the role made by 31 March 2023, the amount of \$20,000 shall be returned to the Funding Board before 30 June 2023.

New Zealand Opera Limited

- A. The proposed increased grant funding for 2022-2023 of \$195,000 is to be specially directed to the following items:
- 1. A contribution to the Audience Development Plan (\$65,000)
- 2. A contribution to paying Auckland artists a living wage for 2022-2023 season (\$60,000)
- 3. Support the bi-cultural journey and permanent establishment of Kaihere Ao (\$70,000)
- B. NZO is to provide updates on the progress against these initiatives with each quarterly report submitted to the Funding Board throughout 2022-2023.

Auckland Philharmonia Orchestra

- A. \$834,729 of the proposed grant is to be applied by the APO to fund stage two (of three) of the move to the new 'Salary Model' introduced in early 2022.
- C) Confirms the total levy requirement for 2022-2023 from Auckland Council as \$16,910,479 and requests the Advisory Officer to advise Auckland Council in accordance with the provisions in the Act.
- D) Adopts the 2022-2023 Funding Plan, subject to the Funding Plan and Annual Report Working Group being authorised to update the 2022-2023 Funding Plan to make any

editorial changes necessary to finalise the plan.

E) Requests the Advisory Officer to distribute the final 2022-2023 Funding Plan in accordance with the provisions in the Act.

Should Auckland Council reject the proposed levy it will be necessary to develop an alternative set of resolutions that sets out the process for the board to follow to finalise the levy, including establishing a working group with delegated authority to undertake the steps necessary to conclude the levy setting process for 2022-2023.
