**SUBMITTER: WESTGATE JOINT VENTURE**

1. Pursuant to section 274 of the RMA, Westgate Joint Venture ("**WJV**") hereby gives notice of its wish to be party to an appeal by Bunnings against a decision of Auckland Council ("**the Council**") on the Auckland combined plan, now the Auckland Unitary Plan: Operative in Part, ENV-2016-AKL-232.
2. The appeal concerns the Council's acceptance of the Independent Hearing Panel's recommendation that it approve I610.10.1. Redhills Precinct: Precinct plan 1 ("**Redhills Precinct**") on 27 July 2016, and in particular the inclusion of arterial roads amended from those which were indicated in submissions, and the provision of a new arterial connection to the Don Buck Road/ Fred Taylor Drive roundabout.
3. WJV is not a trade competitor for the purposes of section 308C of the RMA.
4. WJV made submissions and further submissions on the proposal, namely submissions and further submissions seeking the inclusion of a Precinct Plan for the area now known as the Redhills Precinct in the Unitary Plan.
4. WJV has an interest in the proceedings that is greater than the interest the general public has, because WJV owns lands affected by the Redhills Precinct.
5. WJV takes a neutral stance on the relief sought.
