Subject: Plan Modification: Clause 20A Amendment to Chapter D18 and Schedule 15 of

the Auckland Unitary Plan (AUP) Operative in part (15 November 2016).

Delegated authority to T4 manager through Schedule 2A of the Auckland Council Combined Chief Executives Delegation Register (Updated May 2017).

This plan modification requires decision-making pursuant to clause 20A of the First Schedule to the Resource Management Act 1991, as corrections are required to the Auckland Unitary Plan (Operative in Part).

Nature of change	Amendments are required to correct minor errors in information included in Chapter D18 and Schedule 15 of the Auckland Unitary Plan (Operative in Part). These parts of the plan relate to the Specia Character Areas Overlay.		
	Glendowie There is a reference to Glendowie as being part of a Residential Special Character Area Isthmus C in 'Glendowie' within D18.1 Background. There is also one reference to Glendowie in Schedule 15.		
	Parts of Glendowie were included in the SCA overlay in the Proposed Auckland Unitary Plan (PAUP) as notified. However, through the hearings, recommendation and decision process, the SCA overlay was removed from Glendowie. The references to Glendowie in Chapter D18 and Schedule 15 are therefore in error. No part of Glendowie is subject to the SCA overlay as shown in the planning maps.		
	To correct this error, the word 'Glendowie' should be removed from the table in D18.1 (page 3 and page 6) and removed from the description of the St Heliers SCA in Schedule 15 (page 170).		
	Kitchener Street building There is reference in Schedule 14 (15.1.6.14 Special Character Areas Overlay – Business: Sandringham) to a building at 2-6 Kitchener Street that retains a timber weatherboard parapet wall. This parapet		

	wall has been demolished so this reference is now incorrect and should be removed.
Effect of change	The amendments have no effect on cross-referencing or on other sections of the Unitary Plan. The amendments have no effect on the Unitary Plan maps. The effect of the changes proposed is to ensure that minor errors identified in Chapter D18 and Schedule 15 are corrected.

Materials and construction - built fabric

Construction is generally in plastered brick paint finished. Plasterwork is largely painted over, although there are some remnants of unpainted plaster and exposed brick on side elevations. One building at 2-6 Kitchener Street retains a timber weatherboard parapet wall. Upper storey windows were originally timberframed sashes and casements, and many of these remain.

The overlay area is shown on the 13 special character area maps above. The overlay area covers a series of areas including parts of Remuera, Kohimarama, Mission Bay, and St Heliers, and
