Unitary Plan (AUP) Operative in part (15 November 2016).

This plan modification requires decision-making pursuant to clause 20A of the First Schedule to the Resource Management Act 1991, as corrections are required to the Auckland Unitary Plan (Operative in Part).

Nature of change	Amendments are required to correct minor errors in information included in Schedule 14.1 of the Auckland Unitary Plan (Operative in Part) for nine significant historic heritage places.					
	Specifically, amendments are required to nine places identified in Schedule 14.1, as follows:					
	amendment of the name of four places, to correct the New Zealand Archaeological Association site record number (for one place), and to make the name more historically correct (for three places);					
	amendment to the verified location for three places so that the address matches the Historic Heritage Overlay Extent of Place for the place;					
	amendment to the verified lcoation for one place to reflect a changed street name;					
	amendments to the verified legal description for five places so that the legal description is correct; and					
	the amendment of the verified location for one place to correct formatting errors.					
Effect of change	The amendments have no effect on cross-referencing or on other sections of the Unitary Plan. The amendments have no effect on the mapping, except where the name of a historic heritage place is proposed to be amended, and the name of the place will also need to be updated in GeoMaps.
