This plan modification requires decision-making pursuant to clause 20A of the First Schedule to the Resource Management Act 1991, as corrections are required to the Auckland Unitary Plan (Operative in Part).

Nature of change	A map change is required to correct Designation 1836 affecting the property at 116 Ranfurly Road, Alfriston, in the Auckland Unitary Plan (Operative in Part). Designation 1836 is a rollover of Designation 321 in the (legacy) Auckland Council District Plan (Manukau Section) 2002. The boundaries of Designation 1836 at 116 Ranfurly Road, Alfriston in the Auckland Unitary Plan (Operative in Part) however do not correctly reflect the extent of Designation 321 in the legacy plan. This mapping error occurred during the transfer of information into the Unitary Plan and is therefore being corrected.	
Effect of change	The test in determining whether a correction can be dealt with using clause 20A is whether the amendment affects (prejudicially or beneficially) the rights of some members of the public, or whether it is neutral? In this case, the proposed change is considered to be neutral.


