ATTACHMENT E: PART 1

Proposed Decisions relating to Introductory Designations Report

Introduction

This first part of Attachment E relates to Panel recommendations contained in the Introductory Designations Report. The Introductory Designations Report can be viewed [here](#).

Sections 2.2, 3.2 and 4.2 of the Introductory Designations Report contain recommendations (with accompanying reasons), all of which are proposed to be accepted by the Council. These sections of the Introductory Designations Report are reproduced in their entirety below.

Section 2.2 contains a recommendation that introductory text relating to designations in Part 7 of the PAUP as notified be amended and relocated into a new Chapter K. It is proposed that this recommendation be accepted by the Council with a minor alteration to correct an erroneous reference to the outline colour employed in the planning maps to depict designations.

Sections 3.2 and 4.2, while framed as Panel recommendations, rely on subsequent recommendations in Specific Designation Reports. They contain explanation and recommendations as to the approach to be taken to lapse dates for designations (3.2) and cross-referencing to external plan provisions (4.2). For completeness, however, it is proposed that the Council formally accept the statement of the Panel's approach in each case (in addition to accepting the specific subsequent recommendations in the Specific Designation Reports).

Proposed decisions by Council on Panel recommendations:

1. Panel recommendation relating to Section 2 of Introductory Designations Report

- (a) That the following Panel recommendation in section 2.2 of the Introductory Designations Report be **ACCEPTED** subject to the minor alteration recorded below:

2.2. Panel recommendation and reasons

The Panel agrees with Auckland Council's amendments to Chapter G1.3 and Using Part 7 as set out in attachment C to the evidence of Bain Cross dated 22 October 2015. The text recommended by the Panel is set out in Attachment 1 to this report. The Panel has renamed and renumbered these sections of the Plan.

- (b) That the following minor correction (highlighted yellow, new text shown in double-underlining, deleted text shown with ~~double-strikethrough~~) be made to the Panel's recommended text at Attachment 1 to the Introductory Designations Report pursuant to section 148(5) and (6) of the Local Government (Auckland Transitional Provisions) Act 2010:

~~An overlay~~ A "tan brown" or ~~"red"~~ "dark brown" outline on the planning maps for each designation and NoR, which shows the extent of the designation boundaries.

2. Panel recommendation relating to Section 3 of Introductory Designations Report

- (a) That the following recommendation in section 3.2 of the Introductory Designations Report as to the Panel's overall approach to addressing lapse dates for designations be **ACCEPTED**, while noting that the Panel implements this approach in reports on individual designations:

3.2. Panel recommendation and reasons

A significant number of designations that have not been given effect have had their lapse dates rolled over into the PAUP and expressed as:

- i. "XX years from the date the Plan is made operative";*
- ii. "XX from the date the designation is included in the Plan";*
- iii. "XX years".*

The Panel has two key concerns about this practice. The first is that because the lapse date is not expressed as a specific date (e.g. 31 August 2019) the rollover is enabling the lapse date to be extended and in some cases doubled without any scrutiny or the need for the requiring authority to justify the extension. If the lapse date continues to be expressed simply as a period, then this issue will arise again at the next plan review.

The second concern the Panel has is that if the lapse dates are expressed only as a period this could lead to uncertainty and potential disputes over when the designation lapses.

To address these concerns, the Panel's preference is that the lapse date is expressed as a specific date. This has been discussed with the requiring authorities during the preparation of the reports and during the hearing. The requiring authorities agreed on an assumed date for the Unitary Plan to become operative as being 31 August 2017 and that has become the starting date for setting the lapse periods. For example if the lapse date was previously expressed as "five years

from the Plan becoming operative” it is now expressed as “31 August 2022”.

Modifications to the lapse date to express it as a specific date have either been initiated by the requiring authorities or made by the Panel where it has the jurisdiction. ...

3. Panel recommendation relating to Section 4 of Introductory Designations Report

- (a) That the following recommendation in section 4.2 of the Introductory Designations Report as to the Panel’s overall approach of avoiding cross-references in designations to provisions in operative plans or the Proposed Auckland Unitary Plan be **ACCEPTED**, while noting that the Panel implements this approach in reports on individual designations:

4.2. Panel recommendation and reasons

The Panel’s preference is for designation conditions to be self-contained and not reference operative plans or the Proposed Auckland Unitary Plan/Unitary Plan. The Panel has adopted this approach because of its concern about the difficulty of keeping track of the provisions that applied when designation was confirmed.

Accordingly the Panel in its reports on individual designations has recommended changes to conditions that include the wording of the relevant plan provisions.

Summary:

- The original conditions of this designation related to the Ormiston Road widening and therefore the conditions have been revised accordingly. The modification corrects a reference in the designation conditions. This involves no more than a minor change to the effects on the environment associated with the use or proposed use of land or any water concerned.

Recommendation:

That the following Panel recommendation at section 4 of the above report be **ACCEPTED**:

"The Auckland Unitary Plan Independent Hearings Panel recommends that Auckland Council confirms the notice or requirement for the modifications to the Designation 613 included in the Proposed Auckland Unitary Plan."

2. Report entitled *"Report to Auckland Council Hearing topic 074 Designations – Auckland Council – Designations 420 and 607, Cemeteries May 2016"*

Summary:

- Applies to 420: Swanson Cemetery and 607: Manukau Memorial Gardens (both designations given effect to);
- Modified as part of the 'rollover' process;

- Modifications for 420 Swanson Cemetery standardise conditions in regard to works not requiring an outline plan and standard cultural/heritage/archaeological condition;
- Modifications for 607: Manukau Memorial Gardens modify the purpose from 'Crematorium', 'Cemetery' and 'Cemetery (Extension)' to 'Cemetery and crematorium', modify conditions to replace existing conditions with standard set of conditions relating to when an outline plan of works is not required, and cultural/heritage archaeological conditions, and to amalgamate three existing operative plan designations from the legacy Manukau District Plan.

Recommendation:

That the following Panel recommendation at section 4 of the above report be **ACCEPTED:**

“The Auckland Unitary Plan Independent Hearings Panel recommends that Auckland Council confirms the notices of requirement for the modifications to designations 420 and 607 included in the Proposed Auckland Unitary Plan.”

3. Report entitled *“Report to Auckland Council Hearing topic 074 Designations – Auckland Council - Minor matters and errors, May 2016”*

[Designations: 400, 401, 402, 403, 404, 415, 416, 418, 426, 427, 429, 430, R431, R432, 600, 601, 603, 604, 605, 608, R609, 616, 417, 424, R431, 527, 528, 551 and 602]

Summary:

- These minor amendments have been made to a large number of regional parks, 417 Rosedale Landfill, 424 Woodglen Road Local park, the new designation for Regional Parkland at Pakiri, 527: Riversdale Road Local and Sports Park, 528 Riverside Road Local and Sports Park Avondale, 551 Captain Springs Road Local and Sports Park Te Papapa, and 602 Regional Botanic Gardens Manurewa;
- Council was the only submitter;
- The amendments are minor because they involve no more than a minor change to the effects on the environment associated with the use or proposed use of land or any water concerned; and involve only minor changes or adjustments to the boundaries of the designation or requirement;
- The amendments to the regional parks will allow wider tracks and trails (3m) and larger toilet blocks (100m²) to be constructed without special consent;
- Designation 417 Rosedale Landfill has its eventual purpose updated, which is now to be a recreation reserve, and applies the Proposed Auckland Unitary Plan standards for odour, dust, and noise (in the meantime);

- Designations 424 Woodglen Road Local Park and R431 Regional Parkland at Pakiri have boundaries that have been corrected;
- Designation 528 Riverside Road Local and Sports Park has been amalgamated with designation 527 and both renamed as Riverside Road Local and Sports Park;
- Designation 551 Captain Springs Road Local and Sports Park has had its yard standard reduced where it adjoins recreation land; and
- Designation 602 Regional Botanic Gardens has been clarified to specify more clearly the wide range of community activities that occur there.

Recommendation:

That the following Panel recommendation at section 4 of the above report be **ACCEPTED:**

“The Auckland Unitary Plan Independent Hearings Panel recommends that Auckland Council recommends to the requiring authority that it confirms the notices of requirement for the modifications to the designations included in the Proposed Auckland Unitary Plan subject to the further modifications shown in Attachment 1 and Attachment 2.”

4. Report entitled “*Report to Auckland Council Hearing topic 074 Designations – Auckland Council – Minor matters and errors, Community Facilities, May 2016*”

[Designations: 414, 519, 520, 521, 522, 524, 526, 534, 538, 540, 541, 543, 544, 548, 550 and 552]

Summary:

- These amendments apply to many of the community facilities such as libraries and halls;
- Auckland Council sought modifications as part of its ‘rolling over’ existing designations;
- The modifications rationalise the designation purposes, correct minor errors in the conditions, delete conditions which refer to operative plans and delete conditions relating to construction works which have been completed. The modifications involve no more than a minor change to the effects on the environment associated with the use or proposed use of land or any water concerned; and
- The modifications standardise, as far as possible, the range of community activities that is provided for at these properties.

Recommendation:

That the following Panel recommendation at section 4 of the above report be **ACCEPTED:**

“The Auckland Unitary Plan Independent Hearings Panel recommends that Auckland Council confirms the notices of requirement for the modifications to the designations included in the Proposed Auckland Unitary Plan.”

5. Report entitled *“Report to Auckland Council Hearing topic 074 Designations – Auckland Council – Minor matters and errors, Local parks, May 2016”*

[Designations: 421, 422, 423, 501, 510, 514, 515, 516, 523, 525, 527, 529, 530, 531, 533, 535, 539, 542, 545, 546, 606 and 621]

Summary:

- Auckland Council sought modifications as part of its ‘rolling over’ existing designations;
- The modifications involve minor modifications of conditions;
- The modifications standardise, as far as possible, the purpose of the local parks, and the range of activities that are provided for within them.

Recommendation:

That the following Panel recommendation at section 4 of the above report be **ACCEPTED:**

“The Auckland Unitary Plan Independent Hearings Panel recommends that Auckland Council confirms the notices of requirement for the modifications to the designations included in the Proposed Auckland Unitary Plan.”

6. Report entitled *“Report to Auckland Council Hearing topic 074 Designations – Auckland Council – Designations classified as moderately complex, May 2016”*

Summary:

- Auckland Council sought new designations for R431 Pakiri Regional Park, R432 Te Arai Regional Park, and R609 Ambury Regional Park;
- The purpose of the designations is for recreational use (including the ongoing operation and maintenance of trails and visitor infrastructure for informal recreation activities) and for the conservation of natural and cultural values;
- As new designations, an assessment of effects on the environment was carried out as part of confirming the designations;
- Vector Ltd. lodged submissions seeking to preserve access to its transmission lines where they cross the regional parks;
- Following negotiations with Vector, Council and Vector agreed on the wording of conditions that allow Vector access across the regional parks to its transmission lines to carry out maintenance and repairs, and remedy any damage to the parks that may result;

- The Panel has recommended that these new designations be confirmed subject to the agreed conditions.

Recommendation:

That the following Panel recommendation at section 6 of the above report be **ACCEPTED**:

“6.1. Notices of requirement for new designations included in the Proposed Auckland Unitary Plan at the time of notification.

- Auckland Council sought modifications as part of the ‘rollover’ of the designations;
- The purpose of the modifications was to standardise, as far as possible, the range of recreational activities that are provided for at these reserves;
- The modifications standardise, as far as possible, the conditions that apply to these reserves, thereby simplifying their administration;
- The Panel has confirmed the ‘rollover’ with the modifications sought, noting that “The modifications align the purposes and standardise the conditions across the regional park designations. The modifications involve no more than a minor change to the effects on the environment associated with the use or proposed use of land or any water concerned”; and
- There were two submissions from third parties who sought to correct mapping errors in the notified PAUP. The Panel has confirmed these corrections.

Recommendation:

That the following Panel recommendation at section 4 of the above report be **ACCEPTED**:

“The Auckland Unitary Plan Independent Hearings Panel recommends that Auckland Council recommends to the requiring authority that it confirms the notices of requirement for the modifications to the designations included in the Proposed Auckland Unitary Plan subject to the further modifications shown in Attachment 1 and Attachment 2.”
